Foaming Disinfectant Cleaner

DESCRIPTION

A hospital grade foaming disinfectant that cleans, disinfects and deodorizes in one step. Aggressive on a wide variety of soils and safe for use on any water washable surface. Built-in odor counteractants combine with cosmetic grade perfumes to eliminate foul odors and leave the area with a pleasant scent. This dual quaternary formula is virucidal against the HIV-1 (AIDS virus) and Herpes Simplex 2 virus.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

DISINFECTION, DEODORIZATION AND CLEANING - Shake can before using. Hold container six to eight inches from surface to be treated. Spray area until it is covered with white foam. Allow foam to penetrate and remain wet for 10 minutes. No scrubbing is necessary. Wipe off with a clean cloth, mop or sponge. This product will not leave grit or soap scum. For heavily soiled areas, a pre-cleaning step is required before treatment. When used in food processing establishments, cover or remove all food and packaging materials, remove all gross soils, saturate all surfaces with the spray product, scrub to loosen all soils, allow to soak for 10 minutes, thoroughly rinse all wetted and cleaned surfaces with potable water.

MILDEWSTAT - To control mold and mildew on pre-cleaned, hard, non-porous surfaces spray surface to be treated making sure to wet completely. Let air dry. Repeat application at weekly intervals or when mildew growth appears. **BACTERICIDAL ACTIVITY** - When used as directed, this product exhibits effective disinfectant activity against the organisms: Staphylococcus aureus, Salmonella enterica and Pseudomonas aeruginosa and meets AOAC Germicidal Spray Products Test requirements for hospital disinfectants. **FUNGICIDAL ACTIVITY** - This product is fungicidal against the pathogenic fungi, Trichophyton mentagrophytes (Athlete's Foot Fungus) when used as directed on hard surfaces found in bathrooms, shower stalls, locker rooms, or other clean, non-porous,

hard surfaces commonly contacted by bare feet. ***VIRUCIDAL ACTIVITY** - This product when used on environmental, inanimate hard non-porous surfaces exhibits effective virucidal activity against HIV-1 (associated with AIDS). **KILLS HIV-1 ON PRE-CLEANED ENVIRONMENTAL SURFACES/ OBJECTS PREVIOUSLY SOILED WITH BLOOD/BODY FLUIDS** in health care settings (Hospitals, Nursing Homes) or other settings in which there is an expected likelihood of soiling of inanimate surfaces/objects with blood or body fluids, and in which the surfaces/objects likely to be soiled with blood or body fluids can be associated with the potential for transmission of Human Immunodeficiency Virus Type 1 (HIV-1) (associated with AIDS).

SPECIAL INSTRUCTIONS FOR CLEANING AND DECONTAMINATION AGAINST HIV-1 OF SURFACES/OBJECTS SOILED WITH BLOOD/BODY FLUIDS. PERSONAL PROTECTION: When handling items soiled with blood or body fluids, use disposable latex gloves, gowns, masks, or eye coverings. **CLEANING PROCEDURES:** Blood and other body fluids must be thoroughly cleaned from surfaces and objects before application of this product. **CONTACT TIME:** Allow surface to remain wet for 10 minutes. **DISPOSAL OF INFECTIOUS MATERIALS:** Blood and other body fluids should be autoclaved and disposed of according to local regulations for infectious waste disposal.

EFFICACY TESTS HAVE DEMONSTRATED THAT THIS PRODUCT IS AN EFFECTIVE BACTERICIDE, FUNGICIDE AND VIRUCIDE IN THE PRESENCE OF ORGANIC SOIL (5% BLOOD SERUM).

SAFETY INFORMATION

FIRST AID

Call a poison control center or doctor for treatment advice. If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person. If inhaled: Move person

to fresh air. If person is not breathing, call 911 or an ambulance then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.

STORAGE AND DISPOSAL

DO NOT CONTAMINATE WATER, FOOD, OR FEED BY STORAGE OR DISPOSAL.

CONTAINER DISPOSAL - Do not puncture or incinerate! Nonrefillable container. Do not reuse or refill this container. If empty: place in trash or offer for recycling, if available. If partially filled: Call your local solid waste agency for disposal instructions.

PESTICIDE STORAGE - Store in a dry place no lower in temperature than 50°F or higher than 120°F.
